## FINAL CLASS GAME

Championship Won by Seniors From Middlers.

The final class game between the seniors and middlers was played Friday afternoon, resulting in a victory for the seniors.

1907 started the game by kicking off. Clough made a long run almost to 1907's goal line, but 1906 could not gain and lost the ball on downs. 1907 then kicked out of danger. Clough's kick of 50 yards brought the ball very near the middlers goal line when 1907 fumbled and Rainier fell on the ball. On the next play he went across for a touchdown. No goal was kicked. Score; 5—0.

This half ended with the ball in the seniors possession on 1907's 30 yard line.

### SECOND HALF.

In the second half Merritt kicked off to 1907, who returned the ball to the center of the field. Then Clough made a 40 yard run on a trick play to 1907's fifteen yard line. In two rushes Taggart was pushed across for a touchdown. McCarthy kicked the goal. Score; 11—0.

The next touchdown was made by Capt. Cavanaugh, who received the ball on a blocked kick and ran 30 yards for a touchdown, making the score 16—0, in favor of the seniors. Time was called shortly afterwards.

### Honor to Dennison '87.

It was announced Thursday night that Joseph A. Dennison had been appointed first assistant to district attorney elect, John B. Moran, of Suffolk county.

Mr. Dennison was born in Andover, August 19, 1867, and received his education in the Punchard school and at Phillips Academy, graduating in 1887. While at the Academy, he distinguished himself as a football player and captained the team in 1886. He coached the team of '88 which beat Exeter in a memor-game able 10-0. It was in this that the famous "criss cross" was first used by Mr. Dennison, who gave the signal from the side lines which enabled "Pop" Bliss to make his famous 100 yard run for a touchdown.

On graduating he entered Dartmouth college but before he had completed his course he was compelled to leave and to go to work. A few years later he entered Harvard college, graduating in 1891. Here he also was a distinguished football player, winning the famous undergraduate cup for goal kicking in 1890. He then became a newspaper reporter, but later gave it up and took up the study of law.

His advancement in this work has been rapid and he is regarded as one of the ablest lawyers in Boston.

## ASSOCIATION FOOTBALL

Andover and Fore Rivers Will Play on Brothers' Field This Afternoon.

A splendid opportunity will be afforded the fellows this afternoon to witness the game of association football between two of the leading teams of the State, Andover and Fore Rivers. The game will begin at 2.45, and a great contest is expected.

Up to date, the Fore Rivers have a clean slate, no team this season having been able to beat them. Andover has not played them this season, the game scheduled between the two clubs early in October having been postponed on account of the international game in Boston with the Pilgrims, the All England eleven. Of the members of the greater Boston team which played against the Pilgrims, three players, McAllister, McGregor, and D. McDonald, were from the Fore River team.

Fore River is a strong, all-round aggregation, and the secret of its success is team play. The same eleven men have played practically every game this season, and they know each other's play to a nicety. Their combination is good, and they play the passing game well.

Andover has played a like number of games as its opponents, but has not been quite so successful. While only beaten once, they have been tied three times. The members are much lighter and smaller than the Fore River team, and have not had an opportunity to perfect their team work to as high a degree, owing to the many changes among the forwards from week to week. They are an aggressive and speedy lot, however, play a clean game, and never let up until the final whistle blows. They can play the passing game to perfection, but their lack of weight handicaps the forwards in front of goal. Only one of the Andover players, Ross, the outside left forward, was on the Greater Boston team. R. Anderson captains the eleven and is a most spirited player.

## Forum

Forum met last night to hold the fourth debate in the tournament. In order not to detain the judges any longer than necessary, the debate was taken up immediately. The subject was as follows: Resolved, that the members of the Cabinet should have a seat and be allowed to speak in Congress.

The judges decided the debate in favor of the negative, after which the meeting adjourned.

### Mock Trial at Philo.

Last evening, promptly at 7.30 Judge Deming brought down his gavel and the mock trial began. Stern was the prisoner and was charged with the theft of a 60 horse power automobile. After Reynolds, the prosecuting attorney, had presented the case, he called his witnesses and they were sworn in by the clerk. The witnesses seemed to prove the prisoner's guilt conclusively, but the attorney for the defense, T. A. Smith, set up an alibi and the judge in his charge to the jury also was inclined for acquittal. The jury, however, composed of Strong, foreman; Williams, Haskell, Manning, Mitchell and Ogden, brought in a verdict of guilty and the prisoner was sentenced to five years of hard labor.

Under miscellaneous business, it was voted to hold the annual Philo banquet on the Saturday following the Philo-Forum debate.

**HURLEY OUT**

Unable to Play To-Day Because of Clot on the Brain.

It was announced at a mass meeting of the Harvard students held last Wednesday evening that Daniel J. Hurley, captain and full-back of the team, would be unable to play any more this season. In the Carlisle Indian game he was tackled fiercely by their quarterback, Mt. Pleasant, and received an injury which later formed a clot of blood on his brain. He was removed to the hospital, where he is at present.

Hurley was Harvard's best all-round player and was the life of the team. This was his fourth year on the team and his second as captain, and his loss is all the more severe because there is no substitute who can fill his place suitably. A tendon in his leg was torn in the first scrimmage of the season, and he was unable to play until the Indian game. Then his return to the game produced a marked effect upon the team, which rushed the Indians off their feet and scored a touchdown almost immediately.

On the next play the kick-off went over the goal line and Hurley, racing after it, picked it up in the far southwest corner of the field. Although the Carlisle ends were near him he did not make the ball "dead" by touching it down. Instead he waited until the opposing players, believing that the ball was dead, started to walk away from him, and then with the ball securely tucked under his arm he dashed past his own goal line and up the field.

He had reached the twenty-yard line before the Indians had realized that he was after a touchdown, and then they set sail in pursuit.

Mt. Pleasant was the only one of the Carlisle team between him and the five points, and the Indian quarter stood on the 45-yard line awaiting the runner. Hurley attempted to sidestep him, but the Indian went into him with a crash that could be heard all over the enclosure, and Hurley dropped like a log. He did not appear to be seriously hurt, however, as he was on his feet in a few seconds. He rubbed his head as the referee called him back and decided that the ball was dead behind the goal posts.

After that Hurley's playing had a marked falling-off, and he became surly and captious. Before the Dartmouth game he had the whole team on tenterhooks by his criticism of their playing, and the coaches seriously considered the advisability of putting him in the game. He played poorly that day, and finally the team and the coaches began to watch him, as he talked incoherently at times. Wednesday he complained of a pain on the right side of his head, an examination was made, and the clot was discovered.

ROOSEVELT ON FOOTBALL

Says Game should not be Abolished but Improved and Modified.

On account of the present discussion in regard to abolishing football, President Roosevelt has announced the following statement in regard to the game:

1. Football should be retained instead of abolished.

2. Brutality and foul play should receive the same summary punishment given to a man who cheats at cards or who strikes a foul blow in boxing.

3. The umpire must have the widest latitude in enforcing this principle, even to the extent of ordering not only individual players but whole teams off the field.

4. College presidents should hold to the sharpest accountability the umpire who permits foul or brutal football in any game.

5. The permanent removal from the game, not only of the

dirty or brutal player, but also of the man who is not a bona fide student and amateur.

6. It would be a real misfortune to lose so many and vigorous a game as football.

7. Increase the powers of the officials and the severity of penalties in order to permanently abolish brutality and foul play.

8. Establish a uniform eligibility code among the leading universities of the East.

9. The responsible authorities of the several colleges whose teams play together should have what may be called a 'gentleman's' agreement among themselves that the rules should be enforced.
